

## Inter Pipeline Fund Announces March 2012 Cash Distribution

**CALGARY, ALBERTA, March 6, 2012:** Inter Pipeline Fund (“Inter Pipeline”) (TSX: IPL.UN) announced today the declaration of a cash distribution of \$0.0875 per unit for March 2012. This distribution will be paid on or about April 16<sup>th</sup>, 2012 to unitholders of record on March 22<sup>nd</sup>, 2012.

Inter Pipeline believes it is well positioned to maintain its current level of cash distributions to unitholders through 2012 and beyond. This view is based on Inter Pipeline’s continuing strong financial performance, attractive fundamentals in each of its business segments and higher cash flow resulting from organic growth projects currently under development.

### Eligible Investors

Pursuant to Inter Pipeline’s limited partnership agreement dated October 9, 1997, as amended, all unitholders are required to be residents of Canada. A copy of the limited partnership agreement can be found at [www.interpipelinefund.com](http://www.interpipelinefund.com) by selecting “Corporate Governance”. If a unitholder is a non-resident of Canada (“Non-Eligible Unitholder”), he will not be considered to be a member of the partnership effective the date the Class A Units were acquired. Inter Pipeline requires all Non-Eligible Unitholders to dispose of their Class A Units in accordance with the limited partnership agreement.

In most cases, a unitholder with an address outside of Canada will be a Non-Eligible Unitholder.
